That the parties to this Agreement have agreed upon an assumption of the rayments of said note by COMMUNITY BANK AND TRUST COMPANY OF EDGEWATER, Trust No. 87-04415, dated May 12, 1987, and personally guaranteed by ROBERT S. HORN and YETTA B. HORN, upon the terms and conditions set forth below.

Therefore, in consideration of the mutual promises and agreements, and other good and valuable consideration exchanged by and between the parties hereto, said parties do hereby mutually promise and agree as follows:

- 1. COMMUNITY BANK AND TRUST COMPANY OF EDGEWATER as Trustee, aforesaid, ROBERT S. HORN and YETTA B. nor agree to assume the payments of the installment loan in the amount of \$4,345.02 per month, due on the 1st day of each month, commencing on the 1st day of the first month following the closing of the sale of the subject property, until November 1, 1997, unless sooner paid. ROBERT S. HORN and YETTA B. HORN shall have the right to prepay the loan in whole or in part at any time, with a prepayment penalty, as set forth in said Mortgage Note.
- 2. ROBERT S. HORN and YETTA B. HORN do guaranty the payment of said note on or before November 1, 1997, and to assume personal liability for failure to pay the balance of said note on

or before said date and for failure to pay the monthly payments set forth in paragraph number 1, above, all as set forth in a separate Guaranty.

- transfer, convey or assign the title to all or any portion of the real estate described above, or all or any portion of their beneficiar interest in said real estate, or shall contract to do any of the foregoing, UPTOWN NATIONAL BANK OF CHICAGO, at its option, has the unqualified right to accelerate the maturity of said note causing the full principal balance and accrued interest to be immediately due and payable without notice to ROBERT S. HORN and YETTA B. HORN. In all other respects, the parties hereto mutually agree that all the provisions, stipulations, powers and covenants in said Mortgage Note and Mortgage shall stand and remain unchanged and in full force and effect.
- 4. T.M.A. PARTNERSHIP agrees to cause the LA SALLE NATIONAL BANK, as trustee, to convey the subject real estate to COMMUNITY BANK AND TRUST COMPANY OF EDGEWATER. as trustee aforesaid, by a stamped, trustee's deed pursuant to the contract to purchase dated March 14, 1988, subject to the existing, aforesaid Mortgage and Mortgage Note.
- 5. UPTOWN NATIONAL BANK OF CHICAGO agrees to accept payments on the aforesaid note from the prospective purchasers of the real estate, ROBERT S. HORN and YETTA B. HORN, only until November 20, 1997, at which time the balance of said note is payable in full.
- 6. Upon the closing of the sale of the subject property, UPTOWN NATIONAL BANK OF CHICAGO releases RAY R. TAYLOR, ALAN MISALE, DAVID M. Mc CARTY and WILLIAM A. Mc GINTY from
