ORDER

THIS CAUSE coming on to be heard pursuant to the Petition of SUSAN SCHUSS for an increase in child support, the Court having heard the testimony of the parties, and having reviewed the documentation introduced into evidence, and having heard the arguments of counsel, and being fully advised in the premises, the Court does FIND:

A. That the Defendant, GEORGE SCHUSS, has enjoyed a substantial increase in his income since June 15, 1977.

B. That there has been a substantial increase in the needs and expenses of the parties' minor children, STEPHANIE and WENDI, since June 15, 1977.

IT IS THEREFORE ORDERED AS FOLLOWS:

1. That retroactive to June 3, 1981, the Defendant, GEORGE SCHUSS, shall pay unto the Plaintiff, SUSAN SCHUSS, the sum of \$65.00 per week per child (a total of \$130.00 per week) as and for child support for the parties' minor children.

2. That the \$6,100.00 due and owing to Plaintiff from Defendant because of the retroactive nature of this Order shall be paid at the rate of \$10.00 per week until such time as STEPHANIE becomes emancipated; thereafter, the balance due on said amount shall be paid at the rate of \$65.00 per week.

3. That said payments shall be made directly to SUSAN SCHUSS, and not through the Clerk of the Circuit Court.
