PARTIAL RELEASE OF MORTGAGE, SECURITY AGREEMENT AND FINANCING STATEMENT AND  
OF ASSIGNMENT OF RENTS AND OF ASSIGNMENT OF LESSOR'S INTEREST IN LEASE

WHEREAS, First Wisconsin National Bank of Milwaukee, the present owner and holder of the Mortgage, has been requested to release from the lien of the Mortgage, the Released Premises;

NOW THEREFORE, in consideration of the sum of One Dollar and other good and valuable consideration, the said First Wisconsin National Bank of Milwaukee hereby releases from the lien and the operation of the Mortgage the Released Premises, to wit: that certain piece or parcel of land lying and being in the County of Cook, and State of Illinois, known and described as follows, viz:

Unit B-109 and Garage Space B-16 in Carriage Way of Burr Ridge Condominium as delineated on a survey of the following described real estate: Part of lot "B" in Carriage Way, being a subdivision of part of the Southwest 1/4 of Section 19, Township 33 North, Range 12, East of the Third Principal Meridian, and part of the Southwest 1/4 of said Section 19, in Cook County, Illinois; which survey is attached as Exhibit "C" to the Declaration of Condominium recorded as Document 87607850 together with their undivided percentage interest in the common elements.
