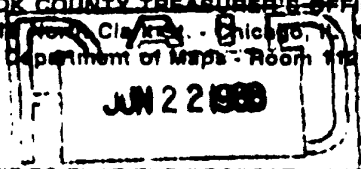

A copy of the affidavit must be served on the owner, part owner or leasee, or his agent, within 30 days after the filing. If neither can be found in the County, then the copy must be posted in some conspicuous place on the premises, within ten days after the expiration of the 30 days. Rev. Code 1311.07.
