ASSUMPTION RIDER

This rider is made this 17th day of June, 1988 and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust, or Security Deed (the "Security Instrument") of the same date given by the undersigned (the "Grantor") to secure Grantor's Note to FLEET MORTGAGE CORP. This fee is automatically waived if the assumer is exempt under the provisions of 38 U.S.C. 1829 (b).
- b. Processing Charge. "Upon application for approval to allow assumption of this loan, a processing fee may be charged by the loan holder or its authorized agent for determining the creditworthiness of the assumer and subsequently revising the holder's ownership records when an approved transfer is completed. The amount of this charge shall not exceed the maximum established by the Veterans' Administration for a loan to which section 1817A of Chapter 37, title 35 United States Code applies."
- c. Indemnity Liability. "If this obligation is assumed, then the assumer hereby agrees to assume all of the obligations of the veteran under the terms of the instruments creating and securing the loan, including the obligation of the veteran to indemnify the Veterins Administration to the extent of any claim payment arising from the guaranty or insurance of the indebtedness created by this instrument."
