### AN ORDINANCE VACATING A PORTION OF A PUBLIC STREET

WHEREAS, the corporate authorities of the Village of Arlington Heights have determined that the public interest would be served by vacating a portion of a public street in the Village of Arlington—Heights, which is hereinafter more particularly described; and

Arlington Heights have determined that the nature and extent of the public use and the public interest to be served is such as to warrant the vacation of that certain portion of the public street,

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF TRE VILLAGE OF ARLINGTON HEIGHTS:

SECTION ONE: That portion of the Boeger Drive right-of-way, at the intersection of Arlington Heights Road, being legally described as:

That part of Boeger Drive is dedicated by North Ridge Subdivision in Arlington Heights, according to the plat thereof recorded July 14, 1977 as Document 24013352 and by Lauria's First Addition according to the plat thereof recorded as Document 86592983, described as follows: beginning at the Northwest Corner of Lot 1 in North Ridge Subdivision in Arlington Heights; thence 00 degrees 00 minutes East along the East line of Arlington Heights Road for 45.50 feet; thence North 90 degrees 00 minutes East for 65.90 feet; thence South 75 degrees 37 minutes 49 seconds East for 84.62 feet; thence south 69 degrees 15 minutes 46 seconds East for 30.70 feet; thence South 00 degrees 00 minutes East for 14.81 15et to a point in the South line of Boeger Drive thence Westerly along the South line of Boeger Drive for 176.58 feet to the place of beginning all in Section 8 Township 42 North, Range 11 East of the Third Principal Meridian, in Cook County, Illinois.
