

A corporation which is to conduct business as a club, as defined in Section 1-3,24 of the "Liquor Control Act" of 1934, must insure that its purpose clause states that it will comply with the State and local laws and ordinances relating to alcoholic liquors.

The registered office may be, but need not be, the same as its principal office. The registered agent may be an individual, resident in this State, or a domestic or foreign corporation authorized to act as a registered agent.

The registered agent cannot be the corporation itself. The registered agent of a corporation shall be the corporation's Secretary or an Assistant Secretary.

NOTE: If a corporation acts as incorporator, the name of the corporation and the state of incorporation shall be shown and the executive officer by its President, Vice-President and Secretary shall be used on certified copies.)

Article 4. Other purposes


- A. To organize and sponsor a twenty-four (24) hour citizen patrol, made up of volunteer residents, as a means of reducing criminal activity
- B. To organize and sponsor a "nosey neighbor" program designed to identify criminal activity
- C. To publish and distribute information to local residents designed to inform and educate the residents on criminal activity and safety information
- D. To organize and sponsor seminars, workshops and discussion groups for the purpose of education and dissemination of information
- E. To conduct various fundraising activities to insure the necessary resources to conduct the affairs of the organization

Article 5. Other provisions

Upon dissolution the remaining assets of the I-Watch Organization will be disposed as follows:

- Technical equipment will be donated to the Phoenix Volunteer Fire Department and the Phoenix Police Department
