was owner's contractor for the improvement thereof.

That on January 12, 1988, said contractor made a subcontract with the claimant to perform plumbing work

for and in said improvement, and that on March 31, 1988, the claimant completed thereunder all required by said contractor to be done

That at the special instance and request of said contractor the claimant furnished extra and additional materials at and extra and additional labor on said premises of the value of \$0- and completed same on 1988

That said owner, or the agent, architect or superintendent of owner (a) cannot, upon reasonable diligence, be found in said County, or (b) do not reside in said County.

That said contractor is entitled to credits on account thereof as follows: payment of \$5,500.00; repair credit \$400.00

leaving due, unpaid and owing to the claimant, after allowing all credits, the sum of Six thousand six hundred and no/100- (\$6,600.00) Dollars, for which, with interest, the claimant claims a lien on said land and improvements and on the moneys or other considerations due or to become due from the owner under said contract against said contractor and owner.
