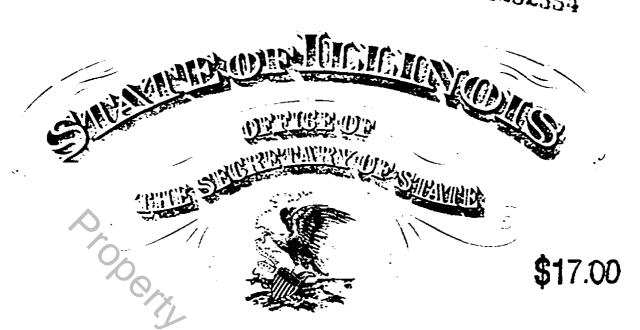

#### ATTACHMENT A

- 1. The Corporation, which is a wholly-owned subsidiary of ROBERTS & SCHAEFER COMPANY, a Delaware corporation, shall be merged with and into ROBERTS & SCHAEFER COMPANY, which shall be the surviving corporation, pursuant to the General Corporation Law of the State of Delaware and The Business Corporation Act of 1983 of the State of Illinois.
- 2. Upon the effective date of the merger, (a) ROBERTS & SCHAEFER COMPANY shall succeed to the property, rights, franchises and assets of every kind and description and liabilities and obligations of the Corporation in the manner set forth in the General Corporation Law of the State of Delaware and The Business Corporation Act of 1983 of the State of Illinois and pursuant to a liquidation of the Corporation effected in accordance with section 332 of the Internal Revenue Code of 1986, as amended, (b) all of the shares of capital stock of the Corporation shall be cancelled, and (c) the distribution to ROBERTS & SCHAEFER COMPANY of the property, rights, franchises and assets of the Corporation effected pursuant to the merger shall be in complete cancellation of all the cutstanding capital stock of the Corporation.
- 3. Each share of capital stock of ROBERTS & SCHAEFER COMPANY issued and outstanding upon the effectiveness of the merger shall remain issued and outstanding shares of capital stock of the surviving corporation, and no securities or obligations of ROBERTS & SCHAEFER COMPANY shall be issued in exchange or conversion for any shares of capital stock or properties in connection with the merger.
- 4. The appropriate officers of ROBERTS & SCHAE-FER COMPANY are hereby authorized, empowered and directed to execute, acknowledge, and file a Certificate of Ownership and Merger in accordance with the General Corporation Law of the State of Delaware and Articles of Merger in accordance with The Business Corporation Act of 1983 of the State of Illinois and to execute such further documents and instruments, to make such other filings and recordings under the laws of such jurisdictions and take such further actions as they deem
