The following sets forth Article IX of the Limited Partnership Agreement dated June 18, 1986.

ARTICLE IX

DISSOLUTION, WINDING UP AND TERMINATION OF THE PARTNERSHIP

- 9.1 Dissolution of Partnership. The Partnership shall be dissolved upon the happening of any of the following events:
- (a) The withdrawal, adjudication or bankruptcy or insolvency of the General Partner;
- (b) The sale or other disposition of all Partnership properties and the distribution to the Partners of all proceeds therefrom: or
 - (c) The expiration of the term of the Partnership.
- 9.2 Winding Up the Partnership. Upon a dissolution of the Partnership, the General Partner shall make an accounting of the Partnership's assets and liabilities.
