- 2. Morigagors shall [1] promptly repair, restore or schuld any building or improvements now or herealise on the premises which may become Camaged or be destroyed, keep said premises in good condition and repair, without waste, and free from mechanic's or other liens or claims for lien not expressly subordanated to the lien hereof, pay when due any indebtedness which may be seemed by a lien or chrige on the premises superior to the lien hereof, and upon request exhibit assistances, exidence of claims for further prior lien to Taustee or to builders of the note; (4) complete within a reasonable time any building or buildings now or at any time in process of cutton upon said premises; (5) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof, (6) make no material alterations and premises except as required by law or municipal ordinance.
