## THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON PAGE I (THE REVERSE SIDE OF THIS TRUST DEED):

- 1. Grantors shall (1) promptly repair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (2) keep said premises in good condition and repair, without waste, and free from mechanic's or other liems or claims for liem not expressly subordinated to the tiem hereof; (3) pay when due any indebtedness which may be secured by a lies or charge on this premises superior to the first hereof, and upon request exhibit satisfactory evidence of the discharge of such prior liem to Trustes or to Beneficiary; (4) complete within a reasonable time any buildings now or at any time in process of erection upon said premises; (5) romply with all requirements of law or municipal ordinances with respect to the premises and the use thereof; (8) make no material alterations in said premises except as required by law or municipal ordinance.
