Lot 4 in Pickwick Ac 2s First Addition, being a subdivision of Lots 4 and 5 (except that part of the East 197 feet of said property lying North of the South 1048 feet thereof) in the subdivision of the East haif of the Northwest quarter and the Northeast quarter of the Southwest quarter of Section 2s, Township 42 North, Range 12, East of the Third Principal Maridian, in Cook County, Illinois.
