PAYMENT AND PERFORMANCE. Except as otherwise provided in this Mortgage, Grantor shall pay to Londer all amounts secured by this Mortgage as they become due, and shall strictly perform all of Grantor's obligations.

REVOLVING LINE OF CREDIT. This Mortgage secures a revolving line of credit as described above. Notwithstanding any other provisions of this Mortgage the following terms and conditions shall apply to the revolving line of credit: (a) Lender will provide Grantor with a final payment notice at least ninely (90) days before the final payment is due. (b) The Note provides that loans may be made from time to time (but in no event later than twenty (20) years from the date of this Mortgage) not to exceed the above stated maximum loan amount outstanding at any one time. Maintenance of Insurance. Grantor shall procure and maintain policies of fire insurance with standard extended coverage endorsements on a replacement basis for the full insurable value covering all improvements on the Real Property in an amount sufficient to avoid application of any coinsurance clause, and with a standard mortgagee clause in favor of Lender. In no event shall the insurance be in an amount less than \$100,000.00. Policies shall be written by such insurance companies and in such form as may be reasonably acceptable to Lender. Grantor shall deliver to Lender certificates of coverage from each insurer containing a stiputation that coverage will not be cancelled or diminished without a minimum of 10 days prior written notice to Lender.

Application of Proceeds. Grantor shall promptly notify Lender of any loss or damage to the Property. Lender may make proof of loss if Grantor fails to do so within 15 days of the casualty. Lender may, at its election, apply the proceeds to the reduction of the indebtedness, payment of any lien affecting the Property, or the restoration and repair of the Property. UCC Remedies. With respect to all or any part of the Personal Property, Lender shall have all the rights and remedies of a secured party under the illinois Uniform Commercial Code.

Collect Rents. To negotiate the same and collect the proceeds. Payments by tenants or other users to Lender in response to Lender's demand shall satisfy the obligations for which the payments are made, whether or not any proper grounds for the demand existed. Lender may exercise its rights under this subparagraph either in person, by agent, or through a receiver.

Mortgagee in Possession.
