THIS INDENTURE, Made July 14, 1988, between ALBANY BANK AND TRUST COMPANY N.A., an association organized under the laws of the United States of America, not personally but as Trustee under the provisions of a Deed or Deeds in trust duly recorded and delivered to said Bank in pursuance of a Trust Agreement dated July 12, 1986 and known as trust number 11-4558, herein referred to as "First Party," and Chicago Title and Trust Company

an Illinois corporation herein referred to as **TRUSTEE**, witnesseth:

THAT, WHEREAS First Party has concurrently herewith executed an instalment note bearing even date herewith in the Principal Sum of **Four Hundred Forty Two Thousand and 00/100-----**

Dollars,

made payable to BEARER

and delivered, in and by which said Note the First Party promises to pay out of that portion of the trust estate subject to said Trust Agreement and hereinafter specifically described, the said principal sum and interest from date of disbursement

on the balance of principal remaining from time to time unpaid at the rate of

10.25% * per cent per annum in instalments as follows: Four Thousand Ninety Four and 61/100-----

Dollars on the 1st day of September 1988 and Four Thousand Ninety Four and 61/100-----

Dollars on the 1st day of each month thereafter until said note is fully paid except that the final payment of principal and interest, if not sooner paid, shall be due on the 1st day of August 1997. All such payments on account of the indebtedness evidenced by said note to be first applied to interest on the unpaid principal balance and the remainder to principal; provided that the principal of each instalment unless paid when due shall bear interest after maturity at the highest lawful rate per annum, and all of said principal and interest being made payable at such banking house or trust company in Chicago, Illinois, as the holders of the note may, from time to time, in writing appoint, and in absence of such appointment, then at the office of Albany Bank and Trust Company N.A., 3400 W. Lawrence Avenue, Chicago, Illinois 60625 in said City.

This loan is payable in full at the end of 9 years. At maturity or if The Holder of the Note demands payment you must repay the entire principal balance of the loan and unpaid interest then due. The Holder of the Note is under no obligation to refinance the loan at that time. You will therefore be required to make payment out of other assets you may own, or you will have to find a lender willing to lend you the money at prevailing market rates, which may be considerably higher than the interest rate on this loan.

A late charge in the amount of 5 % of this monthly payment due hereunder will be assessed for any payment made more than 15 days after the due date.

NOW, THEREFORE, First Party to secure the payment of the said principal sum of money, and have entered into agreement with the Trustee, concerning the limitations of this trust deed, and also in consideration of the sum of One Thousan^d and Sixty Five Dollars, due to First Party, grant, remise, release, alien and convey unto the Trustee, its successors and assigns, the following described Real Estate situated, lying and being in the County of

Cook

AND STATE OF ILLINOIS, to wit

Lot 1 in Wiehe's Subdivision of that part of block 19 lying northerly of the north easterly line of Milwaukee Avenue in Grayland in the Northwest quarter of Section 22, Township 40 North, Range 13, east of the third principle meridian, in Cook County, Illinois.

Commonly known as - 3845 N. Milwaukee Ave., Chicago, Illinois 60641
Permanent Index Number - 13-22-102-013

*The interest rate shall be adjusted to Albank Prime Rate + 1.75% on the first day of August, 1991 and on the first day every three years thereafter until maturity. The payment due for principal and interest shall also be adjusted to reflect any change in the interest rate, based upon the then remaining term.

Prepayment Penalty - 1% prior to June 1, 1997

which, with the property hereinafter described, is referred to herein as the "Premises."

TOGETHER with all improvements,添附物, appurtenances, fixtures, and equipmentizing the real property, and all rents, issues and reversions therefrom during all such times as First Party, its successors or assigns may be entitled thereto, which are placed, planted and set up, placed, attached, fastened, secured and otherwise (whether singly units or centrally controlled), and ventilation, including without restricting the foregoing, central air conditioners, heating ducts and registers, water closets, coverings, indoor beds, awnings, stores and water heaters. All of the foregoing are declared to be a part of said real estate situated as above described and it is agreed that all similar apparatus, equipment or articles hereafter placed in the premises by First Party or its successors or assigns shall be deemed to be constituting part of the real estate.

TO HAVE AND TO HOLD the premises unto the said Trustee, its successors and assigns, forever, for the purposes and upon the terms and trusts herein set forth.

IT IS FURTHER UNDERSTOOD AND AGREED THAT

1. Until the indebtedness aforesaid shall be fully paid, and in case of the failure of First Party, its successors or assigns to do, promptly repair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or destroyed, to keep and maintain as good condition and repair, without waste, and free from mechanic's or other liens or claims for hire not expressly subordinated to the lien hereof, to pay when due any indebtedness which may be accrued by a lien or charge on the premises superior to the lien hereof, and upon request estimate and determine the value of such premises to Trustee or to holders of the notes; (2) complete within a reasonable time any buildings or buildings now or at any time in process of erection, new and otherwise, to comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof; (3) refrain from making material alterations in said premises except as required by law or municipal ordinance; (4) pay before any penalty attaches all general taxes, and pay special taxes, special assessments, water charges, service charges and other charges against the premises when due, and upon written request, to furnish to Trustee or to holders of the note duplicate bills rendered therefor; (5) pay in full under protest, in the manner provided by statute, any tax or assessment which First Party may owe on account of the real estate and improvements thereon; (6) after the premises are sold, pay to the holder of the note the amount of the insurance premium of monies sufficient either to pay the cost of replacing or repairing the same or to pay to fill the indebtedness aforesaid, all in consequence whatsoever, to the holder of the note, under insurance policies payable, in case of loss or damage, to Trustee for the benefit of the holders of the note, with rights to be evidenced by the standard mortgage clause to be attached to each policy; and to deliver all policies, including additional and renewal policies, to holders of the note, and in case of insurance street

to expire, to deliver renewal policies not less than ten days prior to the respective date of expiration; then Trustee or the holders of the note may, but need not, make any payment or perform any act hereinbefore set forth in any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on prior encumbrances, if any, and purchase, discharge, compromise or settle any tax lien or other prior lien or title or claim thereto, or written from any tax sale or forfeiture affecting said premises or contest any tax or assessment. All money paid for any of the above purposes, and all expenses paid or incurred in connection therewith, including attorney's fees and other necessary expenses, shall be advanced by Trustee or the holders of the note to protect the mortgaged premises and the lien hereof, plus reasonable compensation. The sum for which action may be taken, shall be so much additional indebtedness secured hereby and shall become immediately due and payable without notice and with interest thereon at the highest lawful rate per annum. Notice of Trustee or holder of the note shall serve as a waiver of any right accruing to them on account of any of the provisions of this paragraph.

2. The Trustee or the holders of the note hereby secured making any payment hereby authorized relating to taxes or assessments, may do so according to any bill, statement or estimate presented from the appropriate public office without inquiry into the accuracy of such bill, statement or estimate or into the validity of any tax, assessment, sale, forfeiture, tax lien or title or claim thereto.

3. At the option of the holders of the note and without notice to First Party, its successors or assigns, all unpaid indebtedness secured by this trust deed shall notwithstanding anything in the note or in this trust deed to the contrary, become due and payable: (a) immediately in the case of default in making payment of any instalment of principal or interest on the note, or (b) in the event of the failure of First Party or its successors or assigns to do any of the things specifically set forth in paragraph one hereof and such default shall continue for three days, said option to be exercised at any time after the expiration of said three day period.

4. When the indebtedness hereby secured shall become due whether by acceleration or otherwise, holders of the note or Trustee shall have the right to foreclose the lien hereof, in any suit to foreclose the lien hereof, there shall be allowed and included as additional indebtedness in the decree for sale all expenditures and expenses which may be paid or incurred by or on behalf of Trustee or holders of the note for attorneys' fees, Trustee's fees, appraiser's fees, outlays for documentary and expert evidence, stenographer's charges, publication costs and costs (which may be estimated as to items to be expended after entry of the decree) of procuring all abstracts of title, title searches and examinations, guarantee policies, Torrens certificates, and similar data and documents with respect to title to the real estate of the property deemed to be reasonably necessary either to prosecute such suit or to evidence to the court at any trial which may be had, the cause to make known the true condition of the property to or the value of the premises. All expenditures and expenses of this kind shall become no more additional indebtedness secured hereby and shall become due and payable. With interest thereon at the highest lawful rate per annum, when paid or incurred by Trustee or holders of the note in connection with (a) proceedings including probate and bankruptcy proceedings, to which either of them shall be a party, either as plaintiff, claimant or defendant, by reason of this trust deed or any indebtedness hereby secured; or (b) preparations for the commencement of any suit for the foreclosure hereof after accrual of such right to foreclosure whether or not actually commenced; or (c) preparations for the defense of any threatened suit or proceeding which might affect the premises or the security hereof, whether or not actually commenced.

5. The proceeds of any foreclosure sale of the premises shall be distributed and applied in the following order of priority: First, on account of all costs and expenses incident to the foreclosure proceedings, including all such items as are mentioned in the preceding paragraph hereof; second, all other items which under the terms hereof constitute secured indebtedness additional to that evidenced by the note, with interest thereon as herein provided; third, all principal and interest remaining unpaid on the note; fourth, any surplus to First Party, its legal representatives or assigns, as their rights may appear.

6. Upon, or at any time after the filing of a bill to foreclose this trust deed, the court in which such bill is filed may appoint a receiver of said premises. Such appointment may be made either before or after sale, without notice, without regard to the solvency or insolvency at the time of application, or for such receiver, or to exercise any power herein given, unless expressly required by the terms hereof, nor shall Trustee be obligated to record the trust deed or to exercise any power herein given, or to that of the agents or employees of Trustee, and it may require indemnities satisfactory to it before exercising any power herein given.

7. Trustee shall release this trust deed and the lien thereof by proper instrument upon presentation of satisfactory evidence that all indebtedness secured by this trust deed has fully paid and satisfied, and may execute and deliver a release hereof to and at the request of any person who shall, either before or after maturity thereof, produce and exhibit to Trustee the note representing that all indebtedness hereby secured has been paid, which representation Trustee may accept as true without examination. Where a release is requested of an original trustee, such successor trustee may accept as the genuine note herein described any note which bears a certificate of identification purporting to be executed by a prior trustee hereunder or which conforms in substance with the description herein contained of the note and which purports to be executed on behalf of First Party; and where the release is requested of the original trustee and it has never executed a certificate on any instrument identifying same as the note described herein, it may accept as the genuine note herein described any note which may be presented and which conforms in substance with the description herein contained of the note and which purports to be executed on behalf of First Party.

10. Trustee may resign by instrument in writing filed in the office of the Recorder or Registrar of Titles in which this instrument shall have been recorded or filed. In case of the resignation, inability or refusal to act of Trustee, the then Recorder of Deeds of the county in which the premises are situated shall be Successor in Trust. Any Successor in Trust hereunder shall have the identical powers and authority as are herein given Trustee, and any Trustee or successor shall be entitled to reasonable compensation for all acts performed hereunder.

11. For prepayment privilege, see Note hereby secured.

12. In addition to payments to principal and interest hereinabove provided, the Mortgagors shall pay each month to the holder or holders of said Note, 1/12th of the annual general real estate taxes assessed or to be assessed against said premises.

13. The Mortgagors are prohibited from selling, conveying, assigning the beneficial interest in and to, entering into Articles of Agreement for the sale of, leasing, renting, or in any manner transferring title to the mortgaged premises without the prior written consent of the mortgagee. Failure to obtain prior written consent shall constitute a default hereunder entitling the mortgagee to declare the whole of the debt immediately due and payable.

14. The holders of the Note secured by this Trust Deed, at their sole option, reserve the right to extend, modify or renew the Note secured hereby at any time and from time to time. This trust deed shall secure any and all renewals or extensions of the whole or any part of the indebtedness hereby secured however evidenced, with interest at such lawful rate as may be agreed upon and any such renewals or extensions of any charge in the amount or rate of interest shall not impair in any manner the validity of covenants of this Trust Deed nor release the Mortgagors from personal liability for the indebtedness hereby secured. In the event of any extensions, modifications or renewals, extension agreements shall not be necessary and need not be filed.

15. Mortgagors agree that said Note and any extension or renewal thereof as also any and all other indebtedness of Mortgagors to the holders of the Note, heretofore or hereinafter incurred, and without regard to the nature thereof, shall have been paid in full. Mortgagors will not, without the prior written consent of the holders of the Note, create or permit any lien or other encumbrance (other than presently existing liens and liens securing the payment of loans and advances made to them by the holders of the Note) to exist on said real estate, or in transfer, sell, convey or in any manner dispose of said real estate.

16. The real estate described herein shall be, on the obligations and shall also secure, any other liabilities, direct or indirect, absolute or contingent, due or to become due, now existing or hereafter arising, of Mortgagor to Mortgagor or its successors and assigns, provided, however, that in no event shall this Trust Deed secure indebtedness of the Mortgagors to the Mortgagors in an amount exceeding \$1,000,000.00.

17. The Mortgagors hereby waive any and all rights of redemption from sale under any order or decree of foreclosure pursuant to rights herein granted on behalf of the Mortgagors, the Trust Estate, and all persons beneficially interested therein and each and every person acquiring any interest in or title to the premises described herein subsequent to the date of this mortgage, and on behalf of all other persons to the extent permitted by the provisions of Chapter 77, Section 11-B-2(d) Illinois Statutes.

The undersigned will not transfer, assign or in any way hypothecate or attempt to transfer, assign or hypothecate his (its) right, title or interest in and to the premises described herein without first obtaining the written consent of the holder of the Note secured by this Trust Deed.

THIS TRUST DEED is executed by Albany Bank and Trust Company, N.A., not personally but as Trustee as aforesaid in the exercise of the power and authority conferred upon and vested in it as such Trustee (and said Albany Bank and Trust Company, N.A., hereby warrants that it possesses full power and authority to execute this instrument), and it is expressly understood and agreed that nothing herein or in said note contained shall be construed as creating any liability on said First Party or on said Albany Bank and Trust Company, N.A., personally to pay the said note or any interest that may accrue thereon, or any indebtedness accruing hereunder, or to perform any covenant either express or implied herein contained, all such liability, if any, being expressly waived by Trustee and by every person now or hereafter claiming any right or interest hereunder, and that so far as the First Party and its successors and said Albany Bank and Trust Company, N.A., personally are concerned, the last holder of said note and the owner or owners of any indebtedness accruing hereunder shall look solely to the person hereby converted for the payment thereof, by the enforcement of the lien hereby created, in the manner herein and in said note provided or by action to enforce the personal liability of the first notor, if any.


