That on July 8, 1986, the claimant made a contract with Anderson Mikos Architects Ltd., which was authorized or knowingly permitted by said owner to make said contract, to provide structural engineering services in connection with the installation of a magnetic resonance imaging facility at the above location for the sum of \$25,000 plus compensation for additional services, and that claimant has completed thereunder substantially all work required to be performed;

That at the special instance and request of said owner and Anderson Mikos Architects Ltd. the claimant furnished and has completed extra and additional services for said premises of the value of Fifty-Five Thousand Nine Hundred Fifty-Six and 25/100 Dollars (\$55,956.25); and

That said Anderson Mikos Architects Ltd. is entitled to credits on account thereof as follows, to-wit: Eighteen Thousand Six Hundred Twenty and No/100 Dollars (\$18,620) paid to date to claimant for engineering services, leaving due, unpaid and owing to the claimant, after allowing all credits, the balance of Sixty-Two Thousand Three Hundred Thirty-Six and 25/100 Dollars (\$62,336.25) plus unpaid Reimbursable Expenses of Two Hundred Forty-Five and 20/100 Dollars (\$245.20),
