of loss if not made promptly by Mortgagor, and each insurance company concerted is hereby authorized and directed to make payment for such loss directly to the Mortgagee instead of to the Mortgager and the Mortgagee jointly, and the insurance proceeds, or any part thereof, may be applied by the Mortgagee at its option either to the reduction of the indebtedness hereby secured or to the restoration or repair of the property damaged. In event of forcelosure of this mortgage or other transfer of title to the mortgaged property in extinguishment of the indebtedness secured hereby, all property in the interest of the Mortgagor in and to any insurance policies then in force shall pass to the purchaser or grantee.

Notwithstanding the foregoing, this option may notice exercised by the Mortgagee when the ineligibility for insurance in our termit the mortgage insurance premium to the Department c. Ho using and Urban Development.

In the Event of default in making any monthly payment provided for herein and in the note secured hereby for a period of thirty (30) days after the due date thereof, or in case of a bread of any other covenant or agreement herein stipulated, then the whole of said principal sum remaining unpaid together with accrued interest thereon, shall, at the election of the Mortgagee, without notice, become immediately due and payable.
