I, RALPH R. COWERN, of Prospect Heights, Illinois, hereby make this last will and revoke all wills and codicils heretofore made by me.

ARTICLE I

Section 1.1 Payment of Debts, Expenses and Taxes. I direct my Executor, hereinafter named, to pay out of my estate all of my just debts, funeral and administration expenses, including any interest and penalties thereon, which may be assessed in any way by reason of my death.

ARTICLE II

Section 2.1 Beought of My Entire Estate. I give, devise and bequeath absolutely all of my property, real, personal and mixed, of whatsoever character and wheresoever situated, and any interest which I may have in any property, whether in remainder by power of appointment or otherwise, including all lapsed legacies, bequests and devises to my wife, CLAIRE L. COMERN. If my wife does not survive me by ninety (90) days, to such of my descendants as are then living per stirpes, as their absolute property.

Section 2.2 In the event my son, BRADICKO M. COWERN, predeceases me, his share shall go to his descendants per stirpes.

If his descendants per stirpes have not attained the age of twenty-five (25) years, I hereby name my daughter, KIMBERLY LOW COWERN, as Trustee of the funds until the last descendant so effected reaches the age of twenty-five (25) years.

Section 2.3 In the event my daughter, KIMBERLY ANN COWERN, dies leaving no descendants, her share shall go to my son, BRADFORD M. COWERN. If she dies leaving descendants who have not attained the age of twenty-five (25) years, I hereby name my son, BRADFORD M. COWERN, as Trustee of the funds until the last descendant so

ARTICLE III

Section 3.1 Appointment of Executor. I hereby appoint my wife, CLAIRE L. COWERN, to act as Executor of this will. wife is unable or unwilling, then I appoint our friend, CAROL JEAN NELSON, who resides at 100 West Kenilworth, Prospect Heights, Illinois, as Successor-Executor.

Section 3.2 No Sureties Required. I direct that no bond or surety on any bond or other security shall be required of my chosen Executor or Successor-Executor.

Section 3.3 Powers of Executor. In addition to the powers and discretions hereinbefore granted to my Executor and conferred upon my Executor by law, my Executor or Successor-Executor have, subject to the limitation of paying my debts as mentioned in Section 1.1, and without obtaining any order of court, the power to retain or sell any of my property as if she were always the true owner. My Executor or Successor Executor may employ attorneys, auditors, depositories and agents, with or without discretionary powers, and may vote any stocks or any of the rest of my property, either in person or by proxy.

ARTICLE 19

Section 4.1 After Acquired Property. Any and all property acquired after the date of this will shall be disposed of as directed in Section 2.1.

Section 4.2 Captions. The captions contained in this will are for convenience only and are not intended to limit or define the scope or effect of any provisions of this will.

Section 4.3 Grammatical Changes. Any word in the text of this will shall be read as the singular or the plural and as the masculine, feminine, or neuter gender as may be appropriate under the circumstances then existing.

Section 4.4 Simultaneous Death. In the event my wife and I die under circumstances in which there is insufficient evidence to determine which survived the other, my estate shall go to my des-
