SUPPLEMENTARY DECLARATION OF COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS FOR GARIBALDI SQUARE TOWNHOME HOMEOWNERS' ASSOCIATION

This Supplementary Declaration of Covenants, Conditions, Restrictions and Easements for Garibaldi Square Townhome Homeowners' Association made as of this 30th day of June, 1988 by American National Bank and Trust Company of Chicago, not individually but solely as Trustee under Trust Agreement dated November 4, 1987 and known as Trust No. 103932-05 ("Declarant").

WHEREAS, pursuant to the provisions of Article IX, Section 9.2 of the Declaration the Declarant reserved the right to annex to the Parcel and to submi! to the provisions of the Declaration the real estate legally described on Exhibit B attached hereto and defined in the Declaration at the "Additional Land"; and

WHEREAS, the Declarant desires to annex the Additional Land in the manner provided in the Declaration.

NOW, THEREFORE, American National Bank and Trust Company of Chicago, as Trustee as aforesaid and not individually as the legal title holder of the Parcel and the Additional Land hereby annexes the Additional Land to the Parcel and declares that the Additional Land is hereby submitted to the provisions of the Declaration and shall be owned, transfered, reld, sold, conveyed and accepted subject to the Declaration, all the provisions of which shall be deemed to be covenants running with the Additional Land and which shall be binding upon and inured to the benefit of the owners, mortgagees and any other persons from time to time having or acquiring any right, title or interest in the Additional Land or any portion thereof.

THIS SUPPLEMENTARY DECLARATION is executed by the undersigned Trustee, not personally, but as Trustee as aforesaid; and it is expressly understood and agreed by the parties hereto, anything to the contrary notwithstanding, that each and all of the covenants, undertakings and agreements herein made are made and intended, not as personal covenants, undertakings and agreements of the Trustee named and referred to in said Declaration for the purpose of binding it personally, but this instrument is executed and delivered by AMERICAN NATIONAL BANK AND TRUST COMPANY OF CHICAGO, as Trustee, solely in the exercise of the powers conferred upon it as such Trustee, and no personal liability or personal responsibility is assumed by, nor shall at any time be asserted or enforced against AMERICAN NATIONAL BANK AND TRUST COMPANY OF CHICAGO, its agents or employees, on account hereof or on account of any covenant, undertaking or agreement herein, either express or implied, all such personal liability, if any, being hereby expressly waived and released by the other parties hereto, and by all persons claiming by or through or under said parties, and by every person now or hereafter claiming any right hereunder.
