Upon the filing of any complaint to foreclose this mortgage in any Court having jurisdiction thereof, such Court may appoint Bank of Park Forest or any proper person receiver, with power to collect the rents, issues and profits arising out of said premises during the pendency of such foreclosure suit, and until the time to redeem the same from any sale that may be made under any decree foreclosing this mortgage shall expire; and such rents, issues and profits when collected may be applied toward the payment of the indebtedness and expenses and advances herein mentioned and described. 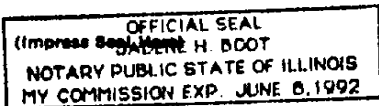
