## Excerpts From Internal Revenue Code

Sec. 6321. Lien For Taxes.

If any person liable to pay any tax neglects or refuses to gity. the same after demand, the amount (including any interest, additional amount, addition to tax, or assessable penalty, together with any costs that may accrue in addition thereto) shall be a like in layor of the tireted States upon all property and rights to property, whether real or personal, belonging to such person.

Sec. 6322. Period Of Lien.

Unless another date is specifically liked by law, the hen imposed by section 8321 shall arise at the time the assessment? is made and shall continue until the liability for the amount so. assessed (or a judgment against the tax payer arising but his such liability) is satisfied or becomes unenforceable by reason of lapse of time.

Sec. 6323. Validity and Priority

Against Certain Persons.

(a) Purchasers, Holders Of Security Interests, Mechanic's Lienors, And Judgment Lien Creditors, -- The lieu imposed by section 6321 shall not be valid as against any purchaser, holder of a security interest, mechanic's lienor, or judgment lien creditor until notice thereof which meets the requirements of subsection (4) has been filed by the Secretary

- " (a) Release Of Lien .- Subject to such requirtiens as the Secretary may prescribe, the Secretary shall issue a certificate of release of any lien imposed with respect to any internal revenes tax not littler than 30 days after the day on
- (1) Liability Satisfied or Unenforceable -- The Secretary finds that the liability for the amount assessed, together with all interest in respect thereof, has been fully satisfied or has become legally unenforceable; or
- (2) Bond Accepted.-There is furnished to the Secretary and accepted by him a bond that is conditioned upon the payment of the amount aspessed, together with all warest in respect thereof, within the lime prescribed by law (including any extension of such time), and that is in accorcar re with such requirements relating to terms, conditions, and form of the bond and sureties thereon, as may be specific 1 by such regulations
