Section 322 of the *R&B Properties Law* requires providers who must exercise the authority of discharge to specify who, and over what period of time, they will discharge more than one mortgage, except that mortgages affected by re-enactments or modifications or cancellations may be included in one which are not. The requirements are set forth in section 322 of the *R&B Properties Law* as follows:

(a) if the mortgage has been assigned, in whole or in part, the certificate shall set forth:

- (i) the date of each assignment, the name of each of the persons or persons signing the certificate, the names of the assignor and assignee, the amount assigned, and
- (ii) if the assignment has been recorded, the date and page where it has been recorded;

(b) the serial number of each record, if any, of the assignment, or being recorded simultaneously with the certificate of discharge, the certificate of discharge shall state, and

- (i) if the mortgage has not been assigned or record, the residence shall be stated;
- (ii) if the mortgage is held by an attorney, managing an executor or administrator, the certificate of discharge shall state the name of the court and the name of the proceedings in which the appointment was made or in which the order or decree creating him such rank, title or authority was passed.
