Section 321 of the Rev. Property Law requires lenders who must execute the certificate of discharge in specific form, and also that the same be recorded in the County Clerk's Office. The certificate shall purport to discharge more than one mortgage, except that mortgages offered to encumbrances in certain cases, spreader contribution in connection may be included in one certificate if the instruments are set forth in order in separate paragraphs. If the mortgage has been assigned in whole or in part, the certificate shall set forth on the date of such assignment in the name of each of the persons or persons signing the certificate, the names of the assignor and assignee, the interest assigned, and if the assignment has been recorded the book and page where it has been recorded, the serial number of such record, the date of the assignment, being recorded simultaneously with the certificate of discharge, the certificate of discharge shall so state, and if the mortgage has not been assigned or if the certificate shall so state; 3) if the mortgage is held by an executor or administrator, the certificate of discharge shall recite the name of the court and the venue of the proceedings in which his appointment was made or in which the order of foreclosure was set aside and the order was entered.
