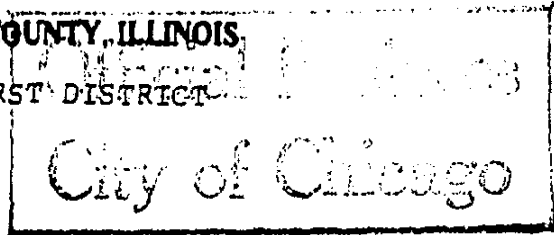

IT IS HEREBY ORDERED that this cause is dismissed without prejudice and no costs, subject to re-inspection as to Count I.

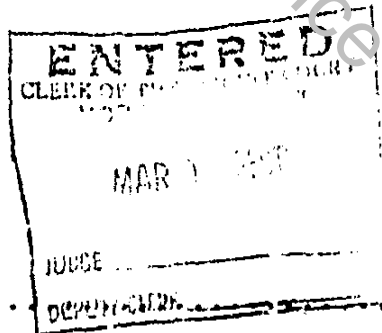
