if the total of the payments made by the Mortgagor under subsection lat of the preceding paragraph shall exceed the amount of the payments actually made by the Mortgagee for ground rents. taxes, and assessments, or insurance premiums, as the case may be, such excess, if the loan is current, at the option of the Mortgagor. shall be credited on subsequent payments to be made by the Mortgagor, or refunded to the Mortgagor. The Security Instrument to which this Rider is attached shall be amended by adding thereto the following described Paragraph:

"The mor(gages shall, with the prior approval of the Federal Housing Commissioner, or his designee, declare all sums secured by this mortgage to be immediately due and payable if all or a part of the property is sold or otherwise transferred (other than by devise, descent or operation of law) by the mortgager, pursuant to a contract of sale executed not later than 12 months after the date on which the mortgage is endorsed for insurance, to a purchaser whose credit has not been approved in accordance with the requirements of the Commissioner. [If the property is not the principal or secondary residence of the mortgagor, "24 months" must be substituted for "12 months."]

The Mortgagor Further Agrees that should this mortgage and the note secured hereby not be eligible for insurance under the National Housing Act, within SIXTY from the date hereof swritten statement of any efficer of the Department of Housing and Urban Development of authorized agent of the Secretary of Housing and Urban Development dated subsequent to the SIXTY time from the date of this mortgage, declining to insure self-note and this mortgage being deemed conclusive proof of such ineligibility sy), the Mortgages or the holder of the note may, at its option declare all sums secured hereby immediately due and payable.
