plaintiff Association is entitled to the possession of the premises described herein.

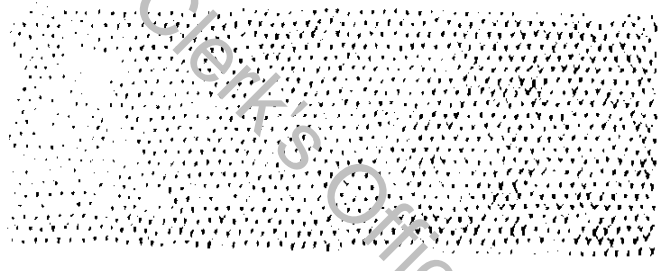
