

SURVEYORS CERTIFICATE OF CORRECTION

I, GEORGE A. SAAM, AN ILLINOIS REGISTERED LAND SURVEYOR, HEREBY CERTIFIES TO THE FOLLOWING CORRECTION TO PLUMWOOD SUBDIVISION, BEING A SUBDIVISION OF THE SOUTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 14, TOWNSHIP 41 NORTH, RANGE 10 EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLAT THEREOF RECORDED MAY 31, 1988 AS DOCUMENT NUMBER 88-231526 IN COOK COUNTY, ILLINOIS.

THE CORRECTION IS AS FOLLOWS:

- 1). THE F.C.M.A. CERTIFICATION SHOWN IN THE SURVEYORS CERTIFICATE STATES THAT LOTS 24 TO 30 BOTH INCLUSIVE ARE SUBJECT TO FLOOD RISK. IT SHOULD READ LOTS 5 TO 8 BOTH INCLUSIVE ARE SUBJECT TO FLOOD RISK.
- 2). THE EASEMENT SHOWN AT THE REAR OF LOTS 1 THROUGH 6, BOTH INCLUSIVE, AT THE EAST LINE OF LOT 106, AND AT THE SOUTH LINE OF LOT 66, READS 10 FEET UTILITY AND DRAINAGE EASEMENT. IT SHOULD READ 12.0 FEET UTILITY AND DRAINAGE EASEMENT.
- 3). THE EASEMENT SHOWN ALONG THE CORTHERLY LINE OF LOT 12, SOUTHERLY LINE OF LOT 15, THE EAST LINE OF LOT 20 AND THE WEST LINE OF LOT 18, SOUTHWESTERLY LINE OF LOT 59, NORTHEASTERLY LINE OF LOT 60, NORTHEAST LINE OF LOT 72, SOUTHWEST LINE OF LOT 74 READS 5.0 FT. UTILITY AND DRAINAGE EASEMENT. IT SHOULD READ 7.0 FT. UTILITY AND DRAINAGE EASEMENT.
- 4). THE EASEMENT SHOWN ALONG THE WEST LINE OF LOTS 29
 THROUGH 32, BOTH INCLUSIVE, READS 10.0 FT. UTILITY AND
 DRAINAGE EASEMENT. IT SHOULD READ 16.0 FT. UTILITY AND


