- (i) I ender waives the provision in Uniform Covenant 2 for the monthly payment to Lender of one-twelfth of the yearly premium installments for hazar, insurance on the Property; and
- (ii) Borrower's obligation under Un form Covenant 5 to maintain hazard insurance coverage on the Property is deemed satisfied to the extent that the required coverage is provided by the Owners Association policy

Borrower shall give I ender prompt notice of any lapse in required hazard insurance coverage

In the event of a distribution of hazard insurance proceeds in heu of restoration or repair following a loss to the Property, whether to the unit or to common elements, any proceeds payable to Borrower are hereby assigned and shall be paid to I ender for application to the sums secured by the Security Instrument, with any excess paid to Borrower.

- C. Public Liability Insurance. Borrower shall take such actions as may be reasonable to insure that the Owners sociation maintains a public hability insurance policy acceptable in form, amount, and extent of coverage to Lender
- D. Condemnation. - (n) any amer direct to any provision of the Constituent Documents if the prevision is for the express benefit of Lender
  - (iii) termination of professional management and assumption of self-management of the Owners Association;
- or (iv) any action which would have the effect of rendering the public hability insurance coverage maintained by the Owners Association unacceptable to Lender
- E. Remedies. If Borrower does not pay condominium dues and assessments when due, then Linder may pay them.
