RESOLUTION NO. 88-105

A Resolution Approving the Final Plat of Michael's Manor 1st Resubdivision (Southwest Corner of Mayer Avenue and Fifth Street)

WHEREAS, Chicago Title and Trust Company, Trustee and Francis E. Abberton, owner, has submitted a final plat of Michael's Manor 1st Resubdivision, prepared by Thomas J. Popke, Illinois Registered Land Surveyor No. 1575, on March 23, 1988, for property located at 53 West Mayer, and 57 West Mayer Avenue, Wheeling, Illinois, hereinafter legally described:

Lots 4 and 5 in Michael's Manor, a resubdivision of part of the South half of Section 2, Township 42 North, Range 11, East of the Third Principal Meridian, in Cook County, Illinois. P.L.N. 03-02-307-018 and 03-02-307-019.

Popke, Illinois Registered Land Surveyor No. 1575, on March 23, 1988, herein attached and made part of:

BE IT FURTHER RESOLVED, that the Village President is directed to sign the Final Plat of Michael's Manor 1st Resubdivision, and the Clerk is directed to affix her signature and seal of the Village thereto, and that the Final Plat of Michael's Manor 1st Resubdivision be recorded on behalf of the Village in the Office of the Recorder of Deeds of Cook County forthwith.
