- 2. This property is subject to the provisions of a Declaration of Condominium Ownership recorded as Document No. 26460487 in the Office of the Recorder of Deeds of Cook County. Article XVI of said Declaration provides for the creation of a lien for the unpaid as sessments of charges levied by the Association, together with interest, costs and reasonable attorneys' fees necessary for collection.
- 3. That the balance of assessments due, unpaid and owing to the claimant on account thereof, after allowing all credits is \$2,481.84 plus attorneys' fees incurred in the sum of \$375.00.
- 4. Each monthly assessment thereafter, beginning September 1, 1988, is in the sum of \$190.25 per month. Said assessments, costs and reasonable attorneys' fees, constitute a lien on the aforementioned
