The Borrower has the right to propay the principal amount outstanding of the Note, in whole or in part, at any time during the term thereof, without penalty.

COVENANTS, Borrower and Bank covenant and agree as follows:

Subject to the rights and terms of any mortgage, deed of trust or other security agreement with a fien that has or appears to have priority over this Mortgage, insurance proceeds shall be applied to restoration or repair of the Property damaged, provided such restoration or repair is accommically feasible and the security of this Mortgage is not thereby impaired.
