AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY OF ELGIN (Country Trails)

WHEREAS, a petition signed by all the owners of record of certain territory has been filed with the City Clerk requesting annexation of said territory to the City of Elgin, Illinois; and

WHEREAS, said petition includes therein a statement under oath by all the owners of record that no electors reside on the subject territory; and

WHEREAS, said territory is contiguous to the City of Elgin and is not within the corporate limits of any municipality; and

WHEREAS, lengt notices of the intent of the City of Elgin to annex said territory have been forwarded to all public bodies required to receive said notice in the manner provided by law.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF \$1.60 ELGIN, ILLINOIS:

Section 1. That the territories and lands described as follows be and after an executed and made a part of the City of Elgin and the boundaries of the City of Elgin be and are hereby enlarged and extended to include in the corporate boundaries of the City of Elgin said territory:

The Northwest Quarter of Section 17, Township 41 North, Range 9 East of the Third Principal Meridian, except that part thereof which lies West of a line which is 40.00 East of and parailel to the East line of the 150 foot right of way conveyed to the Commonwealth Edison Company by deed dated May 14, 1928 as Document 10021928 in Harrover Township, in Cook County, Illinois.

Section 2. That a certified copy of this ordinance together with an accurate map of said territories shall be filed with the Recorder of Deeds, Cook County, Illinois.

Section 3. That this ordinance shall be in full force and effect from and after is passage as provided by law.
