MODIFICATION AGREEMENT

2. The Mortgagors will execute a new Guaranty dated July 15, 1989, in the amount of Eighty Thousand and 00/100 DULL/2S (\$80,000.00).

3. Except for the modifications stated hereinabove, the Second Mortgage

is not otherwise changed, modified or amended.
