Enter the Property. Lender may enter upon and take possession of the Property; demand, collect and receive from the lonants or from any other persons liable therefor, all of the Ronts; institute and carry on all legal proceedings necessary for the protection of the Property, including such proceedings as may be necessary to recover possession of the Property; collect the Rents and remove any tenant or tenants or other persons from the Property.
