- 8. The BORROWER desires to amend the loan amount and maturity date as evidenced by the NOTE and LOAN MODIFICATION AGREEMENT.
- 9. The BANK has agreed to such modification pursuant to the terms and conditions of a commitment letter of the BANK dated March 24, 1989 ("Commitment").

- D. The lien of the TRUST DEED and ASSIGNMENT OF RENTS are hereby modified as security for the payment of the principal sum evidenced by the NOTE and amended by this MODIFICATION AGREEMENT.
