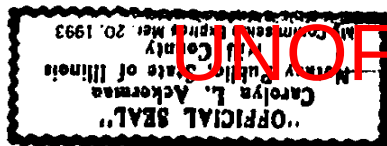

That part of the North half of the South half of the Northeast quarter of Section twenty one (21), Township forty one (41) North, Range thirteen (13), East of the Third Principal Meridian, lying westerly of the westerly line of Cross Point Road (now known as Niles Center Road) and easterly of the easterly line of the Chicago North Shore and Milwaukee Railroad Company right of way being described as follows: beginning at the intersection of the westerly line of Cross Point Road (now known as Niles Center Road) as occupied by and the easterly line of the Chicago North Shore and Milwaukee Railroad Company right of way line; thence Northeast along said westerly line of said Niles Center Road for a distance of two hundred twenty seven and no tenths (227.0) feet to a point thence Northwest at right angles to the last described course, a distance of one hundred twenty eight and seventeen one hundredths (128.17) feet to the easterly line of the Chicago North Shore and Milwaukee Railroad Company right of way line; thence Southeast along said easterly line a distance of two hundred sixty and sixty eight one hundredths (260.68) feet to the place of beginning, in COOK COUNTY, ILLINOIS.**
