STATEMENT OF CLAIM FOR STATUTORY LIEN

The Claimant, CITY OF CHICAGO, a Municipal Corporation, by virtue of the authority granted by Chapter 24, Section 11-126-4, of the Illinois Revised Statutes (1987) and Chapter 185 and 185.1 of the Municipal Code of the City of Chicago hereby files its claim for statutory lien against the following premises commonly known as 3500-04 W. Jackson and legally described as:

The East 10 feet of Lot 36 and all of Lots 37 and 38 in Block 6 in Central Park Addition to Chicago said Addition being a Subdivision of that part of the West 1/2 of the Northeast 1/4 lying North of Barry Point Road of Section 14, Township 39 North, Range 13, East of the Third Principal Meridian, in Cook County, Illinois.

Title to the above described property now appears in the name of Exchange National Bank as Trustee, Trust #32091 of Cook County, Illinois, but the lien is absolute as to all parties of interest.

A F F I D A V I T

Isaac S. Carothers, Superintendent of Water Collection, being first duly sworn, deposes and states that he has examined the records of the Department of Water and has knowledge of the following:

1. That water was furnished by the City.
2. That said water service was and continues to be provided to the following premises commonly known as 3500-04 W. Jackson and legally described as:

The East 10 feet of Lot 36 and all of Lots 37 and 38 in Block 6 in Central Park Addition to Chicago said Addition being a Subdivision of that part of the West 1/2 of the Northeast 1/4 lying North of Barry Point Road of Section 14, Township 39 North, Range 13, East of the Third Principal Meridian, in Cook County, Illinois.

3. That the quantity of water furnished was approximately 1,020,000 cubic feet.

4. That the above water service was furnished by Claimant at the rate as provided in Chapter 185 of the Municipal Code of the City of Chicago.

5. That the amount of money currently due for water service therefore is \$7,729.27.

6. That sewer service and use of the sewerage system was furnished by the Claimant to the said premises.

7. That the above sewer service and use of the sewerage system was furnished at the rate as provided in Chapter 185.1 of the Municipal Code of the City of Chicago.

8. That the amount currently due for sewer service therefore is \$4,719.59.


9. That the total currently due therefore is \$12,448.86.

10. That the above amounts became delinquent on August 15, 1989.

11. That notice of filing this claim was mailed to the "owner or owners and party or parties" interested in the premises located at 3500-04 W. Jackson on August 25, 1989.

12. That less than four months have elapsed since the above amount became delinquent.

13. That as of this date said owner(s), titleholder(s), is/are not entitled to any credits on account, leaving due unpaid and owing to the claimant on account thereof, the balance of TWELVE THOUSAND FOUR HUNDRED FORTY-EIGHT AND 26/100 (\$12,448.86) DOLLARS, for which, with statutory interest, the claimant claims a lien against the above described real estate.



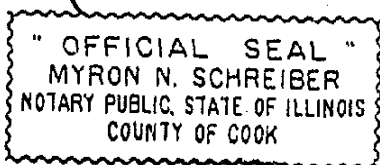
