## TERMINATION AGREEMENT

This Termination Agreement is made this 6th day of September 1989 by and between LaSalle National Bank as trustee under trust No. 35068 dated the eleventh day of May, 1966 (LaSalle) and Christian Communications of Chicagoland, Inc. (Christian Communications).

Christian Communications is the owner of Lots Seven (7) WHEREAS: and Light (8) in Block 3, in Duncans Addition to Chicago, Being a Subdivision of the East 1/2 of the Northeast 1/4 of Section 17, Township 39 North, Range 14 East of the Third Principal Meridian in the City of Chicago, County of Cook, State of Illinois (Parcel B) (P. 1. N. 17-17-207-023 and 17-17-207-019).

On May 11, 1886, the then owners of Parcels A and B WHEREAS: entered into a Party Wall Agreement which inter alia. provided that (1) the then owner of Parcel B proposed to construct a building, in foundation (dimension stones) of which was to extend upon Parcel A and (2) the then owner of Parcel A could construct a building utilizing the west wall of the building that the then owner of Parcel B proposed to construct.

Judah and others and the United Order of American Bricklayers and Stone Masons be and the same is hereby concelled, terminated and rendered null and void and of no continuing force nor effect.
