

(A) Under State Laws

(i) Real Property In the case of real property, in one office within the State (or the county, or other governmental subdivision), as designated by the laws of such State, in

which the property subject to the lien is situated; and
(ii) Personal Property - In the case of personal prop erty, whether langible or intangible, in one office within the State (or the county, or other governmental subdivision), as designated by the laws of such State, in which the property subject to the lien is situated; or

(B) With Clerk Of District Court-In the office of the cterk

of the United States district court for the judicial district in which the property subject to lien is situated, whenever the State has not by law designated one office which meets the requirements of subparagraph (A), or

(C) With Recorder Of Deeds Of The District Of Columbia In the office of the Recorder of Deeds of the District of Columbia, if the property subject to the lien is situated in the District of

- Real property tax and special assessment liens Residential property subject to a mechanic's
- lien for certain repairs and improvements Attorney's liens
- Certain insurance contracts

- (g) Refiling Of Notice. For purposes of this section -
- (1) General Rule. Unless notice of lien is refiled in the manner prescribed in paragraph (2) during the required refilling period, such notice of lien shall be treated as filed on the date on which it is filed (in accordance with subsection (f)) after the expiration of such refiling period.
- (2) Place For Filing.—A notice of lien refiled dur-ing the required rothing period shall be effective only (A) if-
 - (i) such notice of lien is refiled in the office in which

 - the prior notice of lien was filed, and
 (ii) in the case of real property, the fact of refiling is entered and recorded in an index to the extent required by subsection (I) (4), and (B) in any case in which, 90 days or more prior to the date
