The Lien Creditor, VILLAGE OF DOLTON, an Illinois Municipal Corporation, pursuant to the provisions of Section 11-30-7 of the Illinois Municipal Code (Chapter 24, Illinois Revised Statutes), hereby files notice of lien in the favor in the amount of FIFTY AND NO/100 (\$50.00) against the following described real estate:

Calumet Terrace, a sub. of lot 2 to 8 in sub. of the N. 515,10 ft. of the W. 340.89 ft. of the SE 1/4 of Sec. 11-36-14, commonly known as 15136 Woodlawn, Dolton, Illinois - 60419.

That on August 21, 1983, the VILLAGE OF DOLTON caused said weeds to be cut, removed and destroyed, and the reasonable cost and expense incurred for the work was FIFTY AND NO/100 (\$50.00) and that said sum remains unpaid.


