WITNESSETH, that said party of the first part, in consideration of the sum of Ten and no/100 (\$10.00) dollars, and other good and valuable consideration in hand paid, does hereby convey and quitclaim unto said party of the second part, the following described real estate, situated in Cook County, Illinois, to-wit:

That part of Lot 21 in Wellington Court, being a Subdivision of part of the West Half of the Northwest Quarter of Section 33, Township 41 North, Range 10 East of the Third Principal Meridian, according to the Plat thereof recorded December 29th, 1988, as Document No. 88 598 270, described as follows: Commencing at the most Northerly corner of said Lot 21; thence South 36 degrees 40 minutes 00 seconds East along the Northeastly line of said Lot 21 a distance of 73.26 feet to a bend point on the Northeastly line of Lot 21; thence North 88 degrees 16 minutes 50 seconds East along the Northeastly line of said Lot 21 a distance of 21.20 feet for a place of beginning; thence continuing North 88 degrees 16 minutes 50 seconds East along the Northerly line of said Lot 21 a distance of 29.68 feet; thence South 53 degrees 20 minutes 49 seconds West 143.78 feet to a point on the Southwesterly line of said Lot 21; thence North 36 degrees 40 minutes 00 seconds West along the Southwesterly line of said Lot 21 a distance of 17.00 feet; thence North 53 degrees 20 minutes 49 seconds East 139.45 feet to the Place of Beginning; said parcel of land herein described contains 0.060 acres, more or less, in Cook County, Illinois.


