PARTIAL RELEASE OF MORTGAGE

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, Royal St. James, Ltd., a corporation originated under the laws of Illinois, P.O. Box 426, Palos Park, Illinois 60464 ("Mortgagor"), by Mortgage dated May 29, 1987 and recorded in the Office of the Recorder of Deeds of Cook County, Illinois on June 5, 1987 as document number 87305768, and by Assignment of Rents and Leases dated May 29, 1987 and recorded in the Office of the Recorder of Deeds of Cook County, Illinois on June 5, 1987 as document number 87305769 granted and conveyed unto Peoples Savings and Loan Association, F.A. NOW, THEREFORE, in consideration of the payment of ten and 00/100 dollars (\$10.00) to the Lender by Mortgagor at the time of execution hereof, the receipt of which is hereby acknowledged, plus other good and valuable considerations, the receipt and sufficiency of which are hereby acknowledged, Lender does remise, release, quit-claim and discharge from the lien and operation of said Mortgage and Assignment of Rents and Leases unto Mortgagor, and to the heirs and assigns of Mortgagor all that piece, parcel or tract of land being a part of the Mortgaged Premises commonly known as 11525 Old Prague Path, Palos Park, Illinois and legally described as follows:

ALL THAT PART OF LOT 56 IN EDELWEISS IN THE PARK UNIT 2, BEING A SUBDIVISION OF PART OF THE EAST HALF OF THE SOUTHEAST QUARTER OF SECTION 23, TOWNSHIP 37 NORTH, RANGE 12 EAST OF THE THIRD PRINCIPAL MERIDIAN LYING SOUTH OF A LINE THAT IS DESCRIBED AS BEING 83.44 FEET NORTHERLY OF THE NORTHEAST CORNER OF SAID LOT 56 (AS MEASURED ALONG THE EASTERLY LINE OF SAID LOT 56) AND 82.61 FEET NORTHERLY OF THE SOUTHWEST CORNER OF SAID LOT 56 (AS MEASURED ALONG THE WESTERLY LINE OF SAID LOT 56), IN COOK COUNTY, ILLINOIS.

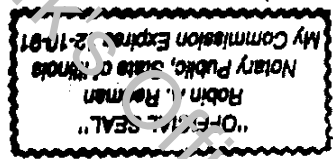
