Whereas MARSHALL SILVER, had petitioned the Board of Managers of Printers Row Condominium to subdivide his unit 2H into Units 212E and 212W respectively with said units being allocated 2.154% ownership of the common elements; and,

Whereas, the Board of Managers, at its meeting held on October 2, 1983, unanimously approved such subdivision,

NOW THEREFORE, IT IS HEREBY RESOLVED

The undersigned, as Owner of the Subject unit and as authorized officer of the board of Managers under that certain Declaration of Condominium Ownership and of Easements, Covenants, and Restrictions for the Printer's Row Condominiums, dated March 7, 1980 and recorded March 19, 1980 as document number 25396708 and in accordance with the powers therein reserved to said Declarant, do hereby amend said Declaration of Condominium Ownership as follows:

1. Exhibit B of the above-described Declaration of Condominium Ownership is amended as set forth herein by subdividing unit 2H into Unit 212W with 1.185 % of ownership of the common element and unit 212E with .969% ownership of the common elements respectively.
2. Exhibit A of the above-described Declaration of Condominium Ownership is hereby amended as set forth on the Amended Page 1 of said survey.

IN WITNESS WHEREOF, MARSHALL SILVER, as owner of the aforesaid unit and the Board of Managers of Printers Row Condominium Association have executed this amendment.


