## EXHIBIT A

### LEGAL DESCRIPTION PARCEL 9

That part of Lot 9 in Wellington Court, being a Subdivision of part of the West Half of the Northwest Quarter of Section 33, Township 41 North, Range 10 East of the Third Principal Meridian, according to the Plat thereof recorded December 29th, 1788 as Document No. 88 598 270 described as follows: Commencing at the most Southerly corner of said Lot 9; thence North 28 degrees 48 minutes 00 seconds West along the Westerly line of said Lot 9 a distance of 92.11 feet for a place of beginning; thence continuing North 28 degrees 48 minutes 00 seconds West along the Westerly line of said Lot 9 a distance of 17.01 feet; thence North 59 degrees 32 minutes 09 seconds East 110.76 feet to a point on a curve, being the Easterly line of said Lot 9; thence Southeasterly along the arc of said curve, being the Easterly line of Lot 9, being concave to the Southwest, having a radius of 270.00 feet, having a chord bearing of South 34 degrees 23 minutes 42 seconds East for a distance of 17.04 feet; thence South 59 degrees 32 minutes 09 seconds West 112.42 feet to the Place of Beginning. said parcel of land herein described contains 0.048 acres, more or less, in Cook County, Illinois.
