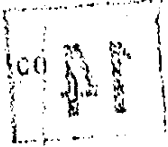

## EXHIBIT A

### LEGAL DESCRIPTION PARCEL 4

That part of Lot 21 in Wellington Court, being a Subdivision of part of the West Half of the Northwest Quarter of Section 33, Township 41 North, Range 10 East of the Third Principal Meridian, according to the Plat thereof recorded December 29th, 1988 as Document No. 88 598 270 described as follows: Commencing at the most Northerly corner of said Lot 21 thence South 36 degrees 40 minutes 00 seconds East along the Northeasterly line of said Lot 21 a distance of 68.40 feet for a place of beginning; thence continuing South 36 degrees 40 minutes 00 seconds East along the Northeasterly line of said Lot 21 a distance of 4.86 feet to a bear point in the Northeasterly line of Lot 21; thence North 88 degrees 16 minutes 50 seconds East along the Northeasterly line of said Lot 21 a distance of 21.20 feet; thence South 53 degrees 20 minutes 49 seconds West 139.45 feet to a point on the Southwesterly line of said Lot 21; thence North 36 degrees 40 minutes 00 seconds West along the Southwesterly line of said Lot 21 a distance of 17.00 feet; thence North 53 degrees 20 minutes 49 seconds East 122.08 feet to the Place of Beginning; said parcel of land herein described contains 0.050 acres, more or less, in Cook County, Illinois.
