THIS INDENTURE, made OCTOBER 20TH 19 89 between THOMAS HICKS

MARRIED TO LJUBINKA HICKS herein referred to as "Mortgagors," and SECURITY PACIFIC FINANCIAL SERVICES INC., an INCORPORATED DELAWARE corporation, herein referred to as TRUSTEE, witnesseth:
