

Sec. 6323. Validity and Priority Against Certain Persons.

(a) Purchaser's, Holders Of Security Interests, Mechanic's Lienors, And Judgment Lien Creditors. -- The Ilen Imposed by section 6321 shall not be valid as against any purchaser, holder of a security interest, mechanic's lianor, or judgment lien creditor upill notice thereof which meets the requirements of subsection (f) has been filed by the Secretary.

m Place For Filing Notice; Form.-

(1) Place For Filling - The notice retorred to in subsection (a) shall be filed .

(A) Under State Laws

(i)" Real Property" In the case of real property, in one office within the State (or the county, or other governmental subdivision), as designated by the laws of such State, in which the property subject to the item is situated; and 1990 (iii) Personal Property In the case of personal prop-

- (1) General Rule. -- Unless notice of then is reflied In the manner proscribed in paragraph (2) during the required refiling period, such notice of tien shall be treated as filed on the data on which it is filed (in accordance with subsection (f)) after the expiration of such refiling period.

(3) Required Refilling Period.—In the case of any notice of lien, the term "required refilling period" means -

(A) the one year period ending 30 days after the expiration of 6 years after the date of the assessment of the lax, and

(B) the one-year period ending with the expiration of 6 years after the close of the proceding jaquired refiling period for such notice of lien.-

> Sec. 6325. Release Of Lien Or Discharge Of Property.

(a) Release Of Lien. — Subject to such regula-lions as the Secretary may prescribe, the Secretary shall issue a certificate of release of any flen imposed with respect to any internal revenue tax not later than 30 days after the day on

(1) Liability Satisfied or Unenforceable - The Secretary finds that the liability for the amount assessed, together with all interest in respect thereof, has been fully setisfied or has become

legally unenforceable; or

(2) Bond Accepted There is furnished to the Secretary and accepted by him a bond that is conditioned upon the payment o. I a amount assessed, together with all interest in respect thereof, within he time prescribed by law (including any extension of unich tiriet, and that is in accordance with such requirements relating to trans, conditions, and form of the bond and sureties thereon as may be specified by such regulations.

k) Disclosure of Certain Returns and Return Information For Tax Administration Purposes.-

(2) Disclosure of amount of outstanding lien.-If a notice of lien has been filed pursuant to section 6323(f), the amount of the outstanding obligation secured by such tien may be disclosed to any person who turnishes satisfactory written evidence that he has a right in the property subject to such lien or intends to obtain a right in such property.
