

Sec. 6322, Period Of Lien,

Unless another date is specifically fixed by law, the lien imposed by section 8321 shall arise at the time the assessment is made and shall continue until the tablity for the amount so assessed (or a ludament against the texpayer arising out of such liability) is setisfied or becomes unenforceable by reason of lapse of time.

Sec. 6323. Validity and Priority Against Certain Persons.

(a) Purchaser's, Holders Of Security Interests, Mechanic's Lienors, And Judgment Lien Creditors. - The tien imposed by section 6321 shall not be valid as against any purchaser, holder of a security interest, mechanic's lienor, or judgment lien creditor until notice thereof which meets the requirements of subsection (f) has been filed by the Secretary,

m Place For Filing Notice; Form. -

(1) Place For Filing - The notice referred to in subsection

(a) shall be filed -(A) Under State Laws

(i) Real Property - in the case of real property, in one office within the State (or the county, or other governmental subdivision), as designated by the faws of such State, in which the property subject to the tien is situated; and 1970

(N) Personal Property - In the case of personal prop erty, whether tangible or intangible, in one office within the State (or the county, or other governmental subdivision), as designated by the laws of such State, in which the property subject to the lien is situated; or

(g) Refilling Of Notice. - For purposes of this section

(1) General Rule,--- Unless notice of lien is reflied in the manner proscribed in paragraph (2) during the required reliting period, such notice of tien shall be treated as filled on the date on which it is filled (in accordance with subsection (f)) after the expiration of such refilling period. ....

(2) Place For Filling:—A notice of tien retilied dur-ing the required retiling period shall be effective only

(A) (i) such notice of lien is refited in the office in which

the prior notice of lien was filed, and

(II) In the case of real property, the fact of reliling is entered and recorded in an index to the extent required by subsection (f) (4), and

(B) in any case in which, 90 days or more prior to the date of a refiling of notice of lien under subparagraph (A), the

Secretary received written information (in the manner prescribed in regulations issued by the Secretary) concerning a change in the laxpayer's residence, if a notice of such lien is also filed in accordance with subsection (f) in the State

(B) the one-year period ending with the expiration of 6 yours after the close of the preceding required refiling period for such notice of lien.

> Sec. 6325. Release Of Lien Or Discharge Of Property.

(a) Release Of Lien. — Subject to such regula-tions as the Secretary may prescribe, the Secretary shall issue a certificate of release of any lien imposed with respect to any internal revenue tax not later than 30 days after the day on

(1) Liability Satisfied or Unenforceable - The Sacretary finds that the liability for the amount assessed, together with all interest in respect thereof, has been fully satisfied or has become

legally unanforceable; or

(2) Bond Accepted There is lumished to the Secretary and except ed by him a bond that is conditioned upon the payment on the amount assessed, together with all interest in respect thereof, within he time prescribed by law findleding any extension of such ".no", and that is in accordance with such requirements relating to lines, conditions, and form of the bond and sureties thereon, ar may be specified by such regulations.

> Sec. 6103. Confidentiality and Disclosure of Returns and Return Information.

(A) Disclosure of Certain Returns and Return Information For Tax Administration Purposes.

(2) Disclosure of amount of outstanding lien,-If a notice of lien has been filed pursuant to section 6323(f), the amount of the outstanding obligation secured by such lien may be disclosed to any parson who fumishes satisfactory written evidence that he has a right in the property subject to such tien or intends to obtain a right in such property.
