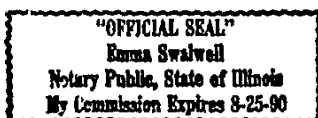

A parcel of land being part of the West half of Lot 2 in the North East quarter of Section 1, Township 35 North, Range 13, East of the Third Principal Meridian, said parcel of land being described as follows: Beginning at a point on the East line of said West half of Lot 2, said point being 50 feet South of the North line of said North East quarter of Section 1 and running thence South along said East line, a distance of 336.75 feet to an intersection with the North Easterly line of the 100 foot right of way of State Route 49; thence South Westerly along the North Easterly line of State Route 49, being a curved line, convex North Westerly and having a radius of 2543.48 feet, a distance of 742.90 feet to an intersection with the Easterly line of the 100 foot right of way of Governors Highway, thence North Easterly along said Easterly line of Governors Highway being a curved line convex South Easterly and having a radius of 4451.46 feet a distance of 819.0 feet, thence North Easterly 4451.46 feet a distance of 819.07 feet, thence North Easterly on a curved line, convex North Westerly, having a common tangent with last described course and having a radius of 50.44 feet, a distance of 71.88 feet to a point of tangency with a line drawn parallel with and 50 feet South of the North line of the North East quarter of Section 1, thence East along said parallel line a distance of 301.61 feet to the place of beginning in Cook County, Illinois. \*\*
