CONSTRUCTION MORTGAGE, ASSIGNMENT AND SECURITY AGREEMENT ASSIGNMENT OF RENTS

THIS CONSTRUCTION MORTGAGE, ASSEGNMENT OF RENTS AND SECURITY AGREEMENT made as of the 24th day of October, 1989, between CONTINENTAL BANK N.A., a national banking association, having its principal office and place of business at 231 S. LaSalle Street, Chicago, Illinois 60697 ("Lender"), HARRIS TRUST AND SAVINGS BANK, not personally but as Trustee under Trust Agreement dated May 23, 1989 and known as Trust No. 94474 ("Borrower") and L&W PARKING VENTURI. an Illinois general partnership ("L&W"). \$34.00

WITNESSETH:

WHEREAS, Borrower and LAW the sole beneficiary of Borrower, have executed and delivered to the Lender (a) a Note Secured by Mortgage of even date herewith payable to the order of Lender in the principal amount of Twenty Five Million Nine Hundred Ninety Nine Thousand Dollars (\$25,999,000), or such lesser amount as may be disbursed thereon, which Note bears interest and is payable to Lender as more fully described therein and which Note shall mature as provided therein but ir no event later than September 4, 1990 unless such note is purchase by Britel Fund Trustees Limited and Possfund Custodian Trustee Limited (collectively the "Fund") on or before September 4, 1990 in which case said Note will mature as provided therein but in no event later than the thirtieth (30) anniversary of the Buy-Sell Data (as hereafter defined) (said note, together with all notes issued in substitution or exchange therefor as any of the foregoing may from time to time be amended, is hereinafter called the "Note"); and

WHEREAS, Lender is desirous of securing the prompt payment of the Note together with interest and any premium thereon in accordance with the terms of the Note and any additional indebtedness accruing to Lender on account of any future payments, advances or expenditures made by Lender pursuant to (i) the Note, (ii) this Mortgage (said Mortgage, as same may be amended from time to time, being herein called the "Mortgage"), (iii) the Construction Loan Agreement of even date herewith between Lender and L&W (said Construction Loan Agreement, as same may be amended from time to time, being herein called the "Loan Agreement"), or (iv) any other document or instrument securing the indebtedness evidenced by the Note;

WHEREAS, it is anticipated that prior to September 4, 1990 the Note, this Mortgage and certain other documents and instruments securing the Note will be purchased by the Fund (the date of such purchase being herein called the "Buy-Sell Date");

NOW, THEREFORE, to secure the performance and observance by the Borrower and L&W of all of the terms, covenants and conditions in the Note, in this Mortgage and in the Loan Agreement contained, and in order to charge the properties, interests and rights hereinafter described with such payment, performance and observance, and for and in consideration of the sum of One Dollar (\$1.00) lawful money of the United States of America to the

Borrower duly paid by the Lender on or before the delivery of this Mortgage, and for other good and valuable consideration, the receipt and sufficiency whereof is hereby acknowledged, the Borrower has executed and delivered this Mortgage and does hereby grant, convey, assign, mortgage, grant a security interest in, warrant and confirm, unto the Lender and its successors and assigns, forever, all of the following described property (which is hereinafter sometimes referred to as the "Mortgaged Property"), to-wit:

- All those certain tracts, pieces or parcels of land more particularly described in Exhibit A attached hereto and made a part hereof (hereinafter called the "Land");
- All buildings, structures and improvements of every nature whatsoever now or hereafter situated on the Land and now or hereafter owned by Borrower and, to the extent now or hereafter owned by Borrower, all furnishings, furniture, fixtures, machinery, equipment appliances, systems, building materials, vehicles and personal property of every kind and nature whatsoever, including, without limitation, all gas and electric fixtures, radiators, heaters, engines and machinery, boilers, ranges, elevators and motors, plumbing and heating fixtures and systems, carpeting and other floor coverings, washers, dryers, water heaters, mirrows, mantels, air conditioning apparatus and water heaters, mirrors, mantels, air conditioning apparatus and systems, refrigerating plant, refrigerators, computers and all therefor, cooking arparatus softvare appurtenances, window screens, awnings and storm sashes which are or shall be attached to said buildings, structures or improvements, or which are a shall be located in, or or about the Land, or which, wherever located (including, without limitation, in warehouses or other storage facilities or in the possession of or on the premises of vendors or manufacturers thereof), are used or intended to be used in or in connection with the construction. fixturing, equipping, furnishing, use, operation or enjoyment of the Land or the improvements thereon, all warehouse receipts or other documents of title relating to my of the foregoing and all permits, licenses and franchises now or hereafter owned by the Borrower, including all extensions, additions, improvements, betterments, renewals and replacements of any of the foregoing, together with the benefit of any deposits or payments now or hereafter made by the Borrower or on its behalf in connection with any of the foregoing; and
- C. All easements, rights-of-way, strips and gores of land, vaults, streets, ways, alleys, passages, sewer rights, waters, water courses, water rights and powers, and all estate, rights, titles, interests, licenses, privileges, liberties, tenements, hereditaments and appurtenances whatsoever, in any way belonging, relating or appertaining to the Mortgaged Property, or any part thereof, or which hereafter shall in any way belong, relate or the appurtenant thereto, whether now owned or hereafter acquired by the Borrower and the reversion and reversions, remainder and remainders, and the rents, issues, profits and revenues of the Mortgaged Property from time to time accruing (including, without limitation, all payrents under leases or tenancies, proceeds of insurance, condemnat on payments, tenant security deposits and escrow funds), and all the estate, right, title, interest, property, possession, claim and demand whatsoever at law, as well as in equity, of the Borrower of, in and to the same;

TO HAVE AND TO HOLD the Mortgaged Property and all parts thereof unto the Lender, its successors and assigns, to its own proper use, benefit and advantage forever, subject, however, to the terms, covenants and conditions herein contained;

WITHOUT limitation of the foregoing, the Borrower hereby further grants unto the Lender, pursuant to the provisions of the Uniform Commercial Code of the State of Illinois, a security interest in all of the above described property, which property includes, without limitation, goods which are or are to become fixtures.

THIS MORTGAGE IS GIVEN TO SECURE: (a) payment of the principal and interest evidenced by the Note; and (b) performance of each and every of the covenants, conditions and agreements contained in this Mortgage, in the Note, in the Loan Agreement, and in any other agreement, document or instrument to which reference is expressly made in this Mortgage or which secures the Note (all of which are sometimes referred to as the "indebtedness secured hereby" or the "indebtedness").

It is expressly understood and agreed that the indebtedness secured hereby will in no event exceed two hundred percent (200%) of the total face amount of the Note.

PROVIDED, HCWLVER, that these presents are upon the condition that, if the Borrower and LEW shall pay or cause to be paid to the Lender the principal and interest payable pursuant to the Note, at the times and in the namer stipulated therein and herein, all without any deduction or credit for taxes or other similar charges paid by the Borrower or LEW, shall pay or cause to be paid all amounts to be paid by LEW under this Mortgage; and shall keep, perform and observe all and singular the covenants and promises in the Note, the Loan Agreement and in this Mortgage expressed to be kept, performed and observed by and on the part of the Borrower or LEW, then this Mortgage shall cease, terminate and he void, but shall otherwise remain in full force and effect.

AND the Borrower covenants and agrees with the Lender that:

ARTICLE I

- 1.01 Performance of Note and Mortgage. The Borrower will perform, observe and comply with all of the provisions hereof and of the Note and will duly and punctually pay to the Lender the principal sum of money expressed in the Note with intrast thereon at the times and in the manner provided in the Note and the Loan Agreement and all other sums required to be paid by the Borrower pursuant to the provisions of this Mortgage, all without any deductions or credit for taxes or other similar charges paid by the Borrower.
- 1.02 <u>Warranty-of Title</u>. At the time of the recordation of these presents, the Borrower is well seized of an indefeasible estate in fee simple in the portion of the Mortgaged Property which constitutes real property and owns good title to the portion of the Mortgaged Property which constitutes personal property, subject only to the matters set forth in Exhibit B attached hereto and made a part hereof, and has good right, full power and lawful authority to convey, mortgage and grant a security interest in the same in the manner and form aforesaid; that the same is free and

clear of all liens, charges, easements, covenants, conditions, restrictions and ancumbrances whatsoever, other than those set forth in Exhibit B, including, as to the personal property and fixtures, security agreements, conditional sales contracts and anything of a similar nature; and that the Berrower shall and will forever defend the title to the Mortgaged Property against the claims of all persons whomsoever.

1.03 Taxes. Borrower will pay before they become due, all taxes, assessments and other similar charges against the Mortgaged Property or any part thereof.

1.04 Taxes, Liens and Other Charges.

- (a) The Borrower will pay promptly, when and as due, and will, upon Lender's request, promptly exhibit to the Lender receipts for the payment of, all taxes, assessments, water rates, license fees, dues, charges, fines and impositions of every nature whatsoever charged, imposed, levied or assessed or to be charged, imposed, levied or assessed or to be charged, imposed, levied or assessed upon or against the Mortgaged Property or any part frarecf; or upon the interest of the Lender in the Mortgaged Property, as well as all income taxes, assessments and other governmental charges lawfully levied and imposed by the United States of America or any state, county, municipality or other taxing authority in respect of the Mortgaged Property or any part thereof, or any charge which, if unpaid, would or could become a lien or charge upon the Mortgaged Property, or any part thereof. PROVIDED THAT hotwithstanding the foregoing, Borrower shall not be required to pay any lien, claim, tax or assessment deemed excessive or invaliu or otherwise contested by Borrower so long as Borrower, in good faith, objects to or otherwise contests the validity of the same by appropriate legal proceedings and Borrower shall as protection and indemnity against loss or damage resulting therefrom, either (1) obtain from the Title Company (as defined in the Loan Agreement) a guaranty or endorsement over such claim or (2) deposit cash, securities or a letter of credit acceptable to Lender in an amount sufficient, in Lender's reasonable judgment, to pay the claim for lien or the unpaid or protested part of any such tax or assessment, together with any costs and penalties thereon which may thereafter accrue, and, in any event, Borrower shall pay any such lien claim, tax or assessment prior to any foreclosure sale foreclosing such lien or any tax sale relating to any such tax or assessment.
- (b) The Borrower will not suffer any mechanic's, laborer's, materialmen's, statutory or other lien or any security interest or encumbrance to be created or to remain outstanding upon any of the Mortgaged Property unless same are bond'd over, or insured by the title company in a manner satisfactory to Lender, in its sole judgment.
- (c) In the event of the passage of any state, federal, municipal or other governmental law, order, rule or regulation, subsequent to the date hereof, in any manner changing or modifying the laws now in force governing the taxation of mortgages or debts secured by mortgages or the manner of collecting taxes so as to affect adversely the Lender, all sums secured by this Mortgage and all interest accrued thereon shall, without notice, become due forthwith at the option of the Lender and payable sixty (60) days after notice to Borrower.

- (d) The Borrower will pay when due any charges for utilities, whether public or private, with respect to the Mortgaged Property or any part thereof and all license fees, rents or other charges for the use of vaults, canopies or other appurtenances to the Mortgaged Property.
- 1.05 No Tax Credits. The Borrower will not claim or demand or be entitled to receive any credit or credits on the principal or interest payable under the terms of the Note or on any other sums secured hereby, for so much of the taxes, assessments or similar charges assessed against the Mortgaged Property or any part thereof, as are applicable to the indebtedness secured hereby or to the Lender's interest in the Mortgaged Property. No deduction shall be claimed from the taxable value of the Mortgaged Property or any part thereof by reason of the Note or this Mortgage.
- 1.56 Insurance. The Borrowar will procure for, deliver to and maintain for the benefit of the Lender during the term of this Mortgage, all insurance required by the Loan Agreement and a policy or policies (i) insuring the Mortgaged Property against fire, lightning vandalism, malicious mischief, all other perils insured against under "extended coverage", and such other insurable perils as the Lander may reasonably require, (ii) affording such other or additional coverage as from time to time may be reasonably requested by the Lender. The Borrower shall pay for all premiums on such policies. The companies issuing such policies, and the amounts, forms, expiration dates and substance of such policies shall be in accordance with the Loan Agreement and such policies shall be in accordance with the Lender, the New York Standard Non-Contributory Mortgagee Clause, or its equivalent, in a form satisfactory to the Lender. At least thirty (30) days prior to the expiration date of each such policy, renewal thereof satisfactory to the Lender shall be delivered to the Lender. The Borrower shall deliver to the Lender receipts evidencing the payment for all such insurance policies and renewals. The delivery of the insurance policies shall constitute an assignment as further security for the indebtedness secured hereby of all unearned premiums. In the avant of the foreclosure of this Mortgage or any other transfer of title to the Mortgaged Property in extinguishment in whole or in part of the indebtedness secured hereby, all right, title and interest of the Borrower in and to all insurance policies then in force thall pass to the purchaser or grantee.

The Lender is hereby authorized and empowered, at its option, to make or file proofs of loss or damage and to adjust or compromise any loss under any insurance policies on the Mortgaged Property, and to collect and receive the proceeds from any such policy or policies. Each insurance company is hereby authorized and directed to make payment for all such losses directly to the Lender instead of to the Borrower. After deducting from said insurance proceeds all of its expenses incurred in the collection and administration of such sums, including attorneys' fees, the Lender may apply, subject to the provisions of Article V of the Loan Agreement the net proceeds or any part thereof, at its option, either toward restoring the Mortgaged Property or as a credit on any portion of the indebtedness secured hereby selected by it, whether then matured or to mature in the future, or at the option of the Lender, such sums either wholly or in part may be paid over to the Borrower, on such terms and conditions as the Lender in its discretion may specify, to be used to repair the

buildings, structures or improvements, or to build new ones in their place, or for any other purpose or object relating to the Mortgaged Property satisfactory to the Lender, without affecting the lien of this Mortgage for the full amount secured hereby before such payment took place. To the extent permitted by law, the Lender shall not be held responsible for any failure to collect any insurance proceeds due under the terms of any policy regardless of the cause of such failure.

Property shall be damaged or taken through condemnation (which term, when used in this Mortgage, shall include any damage or taking by any governmental authority and any transfer by private sale in lieu thereof), either temporarily or permanently, the entire indebtedness secured hereby shall, at the option of the Lender become immediately due and payable. The Lender shall be entitled to all compensation, awards and other payments or relief therefor and is hereby authorized, at its option, to commence, appear in and prosecute, in its own name or, in the event that Borrower bus not assigned its claim to Lender, in the Borrower's name, any action or proceeding relating to any condemnation, and to settle or compromise any claim in connection therewith. All such compensation, awards, damages, claims, rights, actions and proceedings, and the right thereto, are hereby assigned by the Borrower to the Linder. After deducting from said condemnation proceeds all of its expenses incurred in the collection and administration of such sums, including attorneys' fees, the Lender may apply, subject to the provisions of the last paragraph of Section 1.06 above, which shall be applicable to the disbursement of condemnation proceeds, the net proceeds or any part thereof, at its option, either toward restoring the Mortgaged Property or as a credit on any portion of the indubtedness secured hereby selected by it whether then matured or to mature in the future, or for any other purpose or object relating to the Mortgaged Property satisfactory to the Lender without affecting the lien of this Mortgage. The Borrower agrees to execute such further assignments of any compensations, awards, damages, claims, rights, actions and proceedings as the Lender may require. To the extent permitted by law, the Lender shall not be held responsible for any failure to collect any amount in connection with any such proceeding regardless of the cause of such failure.

1.08 Care of the Property.

- (a) The Morrower will preserve and maintain the Mortgaged Property in good condition and repair, will not commit or suffer any waste thereof, and will keep the same in a clean, orderly and attractive condition. The Borrower will not do or suffer to be done anything which will increase the risk of fire or other hazard to the Mortgaged Property or any part thereof.
- (b) Except as otherwise provided herein or in the Loan Agreement, no buildings, structures, improvements, fixtures, personal property or other part of the Mortgaged Property shall be removed, added to, demolished or altered structurally to any extent or altered non-structurally in any material respect without the prior written consent of the Lender.
- (c) If the Mortgaged Property or any part thereof is damaged by fire or any other cause, the Borrower will give immediate written notice of the same to the Lender.

Upon any failure by the Borrower so to do, the Lender may make, execute, record, file re-record and/or refile any and all such mortgages, security agreements, financing statements, continuation statements, instruments, vertificates and locuments for and in the name of the Borrower, and the Borrower hereby irrevocably appoints the Lender the agent and attorney-infact of the Borrower so to do. The lien and security interest hereof will automatically attach, without further act to all after acquired property attached to and/or used in the operation of the Mortgaged Property or any part thereof.

If the Lender so requests, the Borrower shall cause the tenant under each or any of such leases to enter into subordination and attornment agreements with the Lender which are satisfactory to the Lender. The Borrower will not accept payment of advance rents or security de sits equal, in the aggregate, to more than one (1) month's rent without the express written consent of the Lender. In order to further secure payment of the Note and the observance, performance and discharge of the Borrower's obligations hereunder, the Borrower hereby assigns, transfers and sets over to the Lender all of the Borrower's right, title and interest in, to and under all of the leases now or hereafter affecting the Mortgaged Property or any part thereof and in and to all of the rents, issues, profits, revenues, awards and other benefits now or hereafter rising from the Mortgaged Property or any part thereof. Unless and until an L.ent of Default occurs, the Borrower shall be entitled to collect the rents, issues, profits, revenues, awards and other benefits of the Mortgaged Property (except as otherwise provided in this Mortgage) as and when they become due and payable. The Lender shall be liable to account only for rents, issues, profits, revenues, awards and other benefits of the Mortgaged Property actually received by the Lender pursuant to any provision of this Mortgage.

- 1.11 Expenses. The Borrower will immediately upon demand pay or reimburse the Lender for all reasonable attorneys' fees, costs and expenses incurred by the Lender in any proceedings involving the estate of a decedent, an insolvent or a bankrupt, or in any action, proceeding or dispute of any kind in which the Lender is made a party, or appears as an intervenor or party plaintiff or defendant, affecting or relating to the Note, this Mortgage, the Loan Agreement, the Forrower, or the Mortgaged Property, including, but not limited to, the foreclosure of this Mortgage, any condemnation action involving the Mortgaged Property, or any action to protect the security hereof, and any such amounts paid by the Lender shall be added to the indebtedness secured hereby and secured by the lien and wourity interest of this Mortgage, shall bear interest at the rate provided in the Note for interest payable after default (the "Default Rate") and shall be due and payable upon demand.

Not more than once each quarter, the Borrower, within ten (10) days after written request from the Lender, shall furnish a written statement, duly acknowledged, setting forth the unpaid principal of, and interest on, the indebtedness secured hereby and whether or not any offsets or defenses exist against such principal and interest.
- 1.14 <u>Subrogation</u>. The Lender shall be subroyated to the claims and liens of all parties whose claims or liens are discharged or paid with the proceeds of the indebtedness secured hereby.
- other provision hereof, the Borrower will not assign, in whole or in part, the rents, income or profits arising from the Mortgaged Property without the prior written consent of the Lender; any such assignment made without the Lender's prior written consent shall be null and void and of no force and effect and the making thereof shall, at the option of the Lender, constitute an Event of Default under this Mortgage. 1.17 Use of Proceeds.

- (a) The Borrower represents and agrees that the proceeds of the Note secured by this Mortgage will be used for the purposes specified in Paragraph 6404(1)(c) of Chapter 17 of the Illinois Revised Statutes and that the indebtedness secured hereby constitutes a business loan which comes within the purview of said Paragraph 6404(1)(c).
- (b) All agreements between the Borrover and the Lender (including, without limitation, this Mortgage, the Note and any other documents securing the indebtedness secured hereby) are expressly limited so that in no event whatsoever shall the amount paid or agreed to be paid to the Lender exceed the highest lawful rate of interest permissible under the laws of the State of Illinois. Any such sale, assignment or transfer or a sale, assignment or transfer of the beneficial interest in Borrower made without the Lender's prior written consent shall be null and void and of no force and effect, but the attempt at making thereof shall, at the option of the Lender, constitute an Event of Default under this Mortgage.
- 1.19 Prohibition of Further Encumbrance. The Borrower will not, without the prior written consent of the Lender, further mortgage, grant a deed of trust, pledge or otherwise encumber, whether by operation of law or otherwise, all or any of its interest in the Mortgaged Property. Any such encumbrance made without the Lender's prior written consent shall be null and void and of no force or effect, but the attempt at making thereof shall, at the option of the Lender, constitute an Event of Default under this Mortgage.

ARTICLE II

- 2.01 Events of Default. Without limitation of any other provision hereof, the terms "Event of Default" or "Events of Default", wherever used on this Mortgage, shall mean any one or more of the following events:

- (e) The filing by the Borrower or L&W of a voluntary petition in bankruptcy or the Borrower's or L&W's adjudication as a bankrupt or insolvent, or the filing by the Borrower or L&W of any petition or answer seeking or acquiescing in any reorganization, arrangement, composition, readjustment, liquidation, dissolution or similar relief for itself under any present or future federal, state or other law or regulation

- (f) The entry by a court of competent jurisdiction of an order, judgment or decree approving a petition filed against the Borrower or Law seeking any reorganization, arrangement, composition, readjustment, liquidation, dissolution or similar relief under any present or future federal, state or other law or regulation relating to bankruptcy, insolvency or other similar relief for debtors, which order, judgment or decree remains unvacated and unstayed for an aggregate of sixty (60) days (whether or not consecutive) from the date of entry thereof, or the appointment of any trustee, receiver or liquidator of the Borrower of LFW or of all or any part of the Mortgaged Property or of any or all of the rents, issues, profits or revenues thereof without its consent or acquiescence, which appointment shall remain unvacated or unstayed for an aggregate of sixty (60) days (whether or not consecutive); or
- (g) The transfer or further encumbrance of the Mortgaged Property by Borrower not consented to by Lender as described in paragraphs 1.18 and 1.19, respectively, hereof.
- 2.02 <u>Acceleration of Excurity</u>. If an Event of Default shall have occurred and be continuing, then the entire indebtedness secured hereby shall, at the option of the Lender, immediately become due and payable without notice or demand.
- 2.03 Lender's Right to Enter and Take Possession, Operate and Apply Revenues.
- (a) If an Event of Default shall have occurred and be continuing, the Borrower, upon demand of the Lender, shall forthwith surrender to the Lender the actual possession, and if and to the extent permitted by law, the Lender itself, or by such officers or agents as it may appoint, may enter and take possession, of all or any part of the Mortgaged Property, and may exclude the Borrower and its agents and employees wholly therefrom, and may have joint access with the Borrower to the books, papers and accounts of the Borrower.

If default shall occur in the payment, performance or observance of any term, representation, warranty, covenant or condition of this Mortgage (whether or not the same shall constitute an Event of Dafault), the Lender may, at its option, pay, perform or observe the same or take any action necessary to cause any representation of warranty to be true, and all payments made or costs or expenses incurred by the Lender in connection therewith, shall be secured hereby and shall be, without demand, immediately repaid by the Borrower to the Lender with interest thereon at the Default Rate. If the Borrower is a trustee, the Borrower represents that it is the Borrower is a trustee, the Borrower represents that it is the Borrower having the power of direction over it as such trustes to execute this Mortgage, including the foregoing agreements, waivers and releases.
- 2.11 Leases. The Lender, at its option, is authorized to foreclose this Mortgage subject to the rights of any tenants of the Mortgaged Property, and the failure to make such tenants parties to any such foreclosure proceedings and to foreclose their rights will not be, nor be asserted to be by the Borrower, a defense to any proceedings instituted by the Lender to collect the sums secured hereby, or any deficiency remaining unprid after the foreclosure sale of the Mortgaged Property.
- 2.12 Discontinuance of Proceedings and Restoration of the Parties. In case the Lender shall have proceeded to enforce any right, power or remedy under this Mortgage by foreclosure, entry or otherwise, and such proceedings shall have been discontinued or abandoned for any reason, or shall have been determined adversely to the Lender, then and in every such case the Borrower and the Lender shall be restored to their former positions and rights hereunder, and all rights, powers and remedies of the Lender shall continue as if no such proceeding had been taken.
- 2.13 <u>Remedies Cumulative</u>. No right, power or remedy conferred upon or reserved to the Lender by this Mortgage is intended to be exclusive of any other right, power or remedy, but each and every such right, power and remedy shall be cumulative

2.14 Waiver.
